The Committee asked for the speed limit on Jackets Hill, Thakeham to be reviewed against the County Council's new speed limit policy and the results reported to the Committee. This length of road is derestricted currently the subject of a 60mph national speed limit. It can be confirmed that the existing speed limit of 60mph on Jackets Hill in accordance with current advice and best practice is set at a level appropriate for the route. The accident history provides no justification to support funding from the road safety budget to introduce a lower speed limit. As a consequence no further action is proposed at the present time. The Committee is asked to note the report.
