In response to concerns raised by some residents over the levels of weekend parking in various roads within the Three Bridges RPS, a consultation regarding a potential change to the days of operation has recently been undertaken with all residents within the RPS. In tandem with this exercise, residents in various roads on the edge of the RPS in Three Bridges, as well as in Pound Hill, have also been consulted on initial proposals which could lead to their inclusion into the RPS. Officers are of the view that the proposals, incorporating some changes, should progress to the formal consultation stage.

The [attached](#) report by Director of Highways and Transport & Service Manager for Residents & Environmental Services asks the East Crawley County Local Committee to authorise the Director of Law, Assurance and Strategy to formally advertise modified proposals, as described by Option 1 in Appendix C, and subject to there being no unresolvable objections after a formal advertisement, bring the Traffic Regulation Order into operation.
