4. **Urgent Matters**

5. **East Grinstead Controlled Parking Zone – Proposed amendment (Formal Advertisement)**

This [report](#) concerns the results of an informal consultation carried out in East Grinstead in April 2011. Approximately 3000 letters were distributed, asking for the views of residents and businesses on parking issues in their area and whether they supported initial proposals for an amended Controlled Parking Zone. A consultation report has been produced, the contents of which will be presented to County Councillors and officer recommendations on how to proceed. The report seeks the approval of County Councillors to progress with a formal advertisement of proposals later in the year.

6. **Changes to the County Council Financial Support for Non Commercial Bus Network**

The Chairman will explain the reason behind the changes the County Council is making and explain how residents can find more information on routes affected in North Mid Sussex and how they can input into the current bus user survey.

7. **[Turners Hill B2110 proposed 40mph Speed Limit](#)**

Following informal consultation, and with Local County Councillor's support, this proposed speed limit change was advertised by formal public notice between 22nd September and 14th October 2011. As a result one objection was received from a member of the public. The Committee is asked to consider whether it wishes to proceed with the proposal.

8. **[North Mid Sussex CLC Area Infrastructure Plan](#)**

The scope of the Infrastructure Plan is to identify local improvement priorities. Improvements are regarded as additional physical infrastructure assets that offer new community benefits, beyond that typically associated with maintenance works.

The Committee is asked to approve the priorities set out in Appendix A of the report.
