Pagham to East Head Coastal Defence Strategy

I am writing on behalf of the Countryside Access Forum for West Sussex (CAFWS), **an independent statutory advisory body** set up to give access advice to a number of bodies, including all levels of government, in response to relevant consultations. The Forum is keen to contribute to this process to ensure that proposed changes meet the needs of local people and that the chance is taken to improve opportunities for countryside and coastal access for present and future users.

Prior to your recent series of public consultations, CAFWS expressed concern over the possible severance of access between Selsey and East Wittering if the beach is allowed to be breached and rolled back through "managed realignment." (Please see Appendix 1) At your exhibition, your officers gave some reassurance by saying that, during the design stage, it would be quite possible to provide a pathway along any new earth banks that were to be constructed further back. The existing shingle beach is a very important path both as a link between two communities and as leisure route in itself - irrespective of the fact that it is not technically a public right of way. It is well used and valued throughout the year.

CAFWS would be grateful if you could confirm that, if managed realignment takes place, an alternative route will be provided. Moreover, CAFWS hopes that such a path will be designed as a multi-user path - walkers, cyclists and horse riders.

Pagham to East Head Coastal Defence Strategy 2007

Please accept this letter as the response to your consultation paper from the Coastal Plain sub forum on behalf of the Countryside Access Forum for West Sussex – a statutory body created by the government to advise the County Council and others on matters relating to public access to the countryside.

The context of the study is explained in your introduction where you refer to permissive powers to “construct coastal defences to protect people and property where these are economically justified...” You also refer to the EA’s obligation to protect habitats.

However, the public interest is wider and, as you might expect, we are surprised that little attention is paid to the importance of public coastal access. This is particularly ironic as the government are about to consult widely as to how coastal access should be improved. We believe that the EA and the two District Councils do have responsibilities for public access and leisure. Accordingly, we feel that built into the strategy should be an objective to take advantage of any significant changes along the coast to protect and actually improve public access as necessary.

We offer the following comments on the three sections:

1. Pagham Beach, Pagham Harbour and Church Norton – We support the proposed holding the line which will protect the valuable shingle flora and an area of great importance for public access and nature conservation.
2. Selsey and Medmerry – It seems to us to be incongruous to hold the line at East and West Beaches and yet to allow the central vulnerable section to erode, in particular as the collapse of the central defences would threaten the valued continuous coastal public access. At Medmerry we recognise that the track along the top of the beach is not technically a public right of way, despite the fact that it has been used by the public for many years; the loss of this vital direct link between Selsey and East

Wittering we deplore and hope can be reconsidered. If not, then it is essential that advantage is taken of the erection of the new inland banks to create new public rights of way to link the two communities. We are also concerned that the abandonment of the present regime at Medmerry will have a detrimental impact on the drainage of the farmland and a number of footpaths will become unusable.

3. East Wittering, Cakeham and West Wittering – We found your prescription regarding East Head both worrying and confusing. We were worried at the potential loss of regular public access to East Head – surely one of the most popular coastal sites for visitors in the entire county? We are confused because you basically favour natural solutions and yet want to accelerate those changes by removing existing defences. Our understanding is that the position at East Head seems to be relatively stable with some accretion of sand and sediment and we would caution against taking steps which may be to everyone's detriment.

Finally, I shall be grateful if you will note the Forum's interest in access matters and add us to your list of consultees when addressing the next stretch of coastline in West Sussex.
