Report by Director of Law and Assurance

Electoral Divisions: Horsham East and Horsham Hurst

Recommendation

(1) That the County Council supports the Horsham District Council proposal to move the division boundary between Horsham East and Horsham Hurst divisions to move all of Station Road, Horsham, into Horsham Hurst division from 2021.

Proposal

1. Background and Context

- 1.1 Half of Station Road is currently in the Horsham East Division and the other half is in Horsham Hurst Division. At the time of the last County Council boundary review, the County Council sought to move the division boundary to the railway line and North Street, to put all of Station Road into Horsham Hurst Division. The Local Government Boundary Commission for England did not agree to this change on the basis that it would not be coterminous with the district ward boundary.
- 1.2 A boundary review has since been completed for Horsham District Council. The new boundaries will come into effect in 2019. One of the changes has been to move the boundary of the district ward to put all of Station Road into a single ward, using the railway line and North Street as a clearer boundary.
- 1.3 Because of the Horsham District boundary changes, the District Council is undertaking a polling district and boundary review, ready for their 2019 elections. Because of the anomaly in the boundary at Station Road, there is an opportunity to amend the County Council division boundary to move it to the railway line and North Street, to regain coterminosity with the district ward boundary.
- 1.4 The District Council intends to pursue this following the polling review. A map is included as an appendix to show the potential impact of the proposal.

2. Proposal

2.1 It is proposed that the County Council support this change to the boundary so that Station Road would completely fall into Horsham Hurst Division, with effect from the next County election in 2021.
