The Jubilee 2012 working group was set up in February 2011, with the specific objective of organizing a unique Party on the Prom in Worthing to celebrate the Diamond Jubilee. The working group is chaired by Councillor Tom Wye and comprises representatives of the Lions, Rotary, Chamber of Commerce, Town Centre Initiative, WBC, Worthing Police, DSH Leisure, Sunny Worthing Arts Group, Creative Waves, Worthing Journal. The Group draws on volunteers from the Lions, Rotary, schools, artists. Due to the success of the event in 2012, the Working Party decided that this should be an annual event and for 2013 will be linked to the celebration of Sussex Day. The governance and membership of the working group remains unchanged.

The party on the promenade will stretch from Splash Point to George V Avenue, with over 2.7 km of party goers and should involve 6 – 7000 residents. The Promenade is divided into red, white and blue zones with families, community groups and friends being able to book sections of the promenade to set up their own tables and chairs. Entertainment will be provided along the Promenade, with a number of competitions for both children and adults to keep everyone occupied. The competitions will include pavement art, fancy dress and best dressed table.

The funding for this event is vital to ensure that this project will go forward. The events planned are fully inclusive and for 2013 will celebrate Sussex Day. The Working Party gives its time for free in respect of organizing the event and assisting on the day, the volunteer hours will be considerable. The Lions and three Rotary groups will provide the main assistance on the day regarding marshalling the event, the volunteers will number in excess of 100.
