### Highways and Infrastructure

#### Chichester Parking Management Plan: Approval to proceed to formal TRO advertisement

Following the informal consultation exercise in March this year and subsequent discussions with the members of the South Chichester County Local Committee, the Director of Highways, Transport and Planning has now agreed that the proposals (as amended) can proceed to formal advertisement of the necessary Traffic Regulation Orders (TROs). A report approved by the Director provides [further information about the decision](#), including the results of the consultation and the proposed design changes. Work is now proceeding with the production of formal TRO documents, which mainly consist of updates to the 21 zone plans. That work will take some time to finalise, but it is intended to achieve a TRO advert prior to Christmas this year.
