The County Council is required to provide a minimum of 28 days' notice for all key decisions. Key decisions are those which involve expenditure or savings of £500,000 or more or which will have a significant effect on communities in two or more electoral divisions. The Forward Plan, which is updated on a rolling basis, contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months. The current Forward Plan was published on 1 May 2018. Since the last edition of the Members' Information Service changes to the Plan have been made to:

- move any April decisions not yet taken to May;
- remove a decision from the Strong, Safe and Sustainable Place priority - Adoption of a new Framework to deliver Solar Farms and Battery Storage – as a key decision is not required; and
- add three new decisions to the Prosperous Place priority:
  - A27 Chichester Improvements: Submission to the Government's Roads Investment Strategy (June);
  - Review of On-Street Parking Charges and related Policy (June); and
  - A284 Lyminster Bypass – Funding and Full Planning Application (July).
