'As the Select Committee had previewed this decision on two occasions, the focus was on whether any significant new information had become available since the Committee's considerations. The BPG was not persuaded that any significant or new information was available. The BPG felt that the report presented at the 3 September meeting clearly highlighted risks in terms of perceived threats to staff roles, service specialisms and existing service delivery arrangements and outlined a number of measures being taken to mitigate these, including plans to engage further with staff and services in the review and redesign of services. In conclusion, the BPG believed that the Customer Experience Programme had been thoroughly scrutinised by the Performance and Finance Select Committee and therefore declined the request.'

- (ii) Invite SECAMB to share the findings of the Forensic, Patient Impact and Governance reviews, as required by Monitor, as soon after April 2016 with the Committee's Business Planning Group to decide if any further formal scrutiny is required.
