The County Council is required to provide a minimum of 28 days' notice for all key decisions. Key decisions are those which involve expenditure or savings of £500,000 or more or which will have a significant effect on communities in two or more electoral divisions. The Forward Plan, which is updated on a rolling basis, contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months. The current Forward Plan was published on 1 February 2019.

Since the last edition of the Members' Information Service changes to the Plan have been made to:

- move any January decisions not yet taken to February;
- add a new decision to the A Strong, Safe and Sustainable Place priority - *Community Based Social Support* (April); and
- remove the 'Proposed Savings from the Communities and Public Protection budget for 2019/20' decision from the Strategic Budget Options 2019/20 section, as this has now been covered within the Budget Proposal decision ([CAB1\(18/19\)](#)) published on 29 January 2019.
