Adults' Services has started to trial its vision for the future with a new operating model for the delivery of its social care services. It aims to reach out to people in their communities to help support their independence and quality of life. The teams in those areas will meet people, their families and carers in local settings to talk about the support they need and will help people make the best use of their strengths, including family and community networks.

There are four innovation site areas around the county, with Sompting and Lancing, and West Crawley recently underway. The rural area north of Chichester will begin at the end of February, with East Grinstead starting mid-March. This along with extensive engagement with a wide range of stakeholders will help to develop and refine the
