The Forward Plan contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months. Key decisions are those which involve expenditure or savings of £500,000 or more or which will have a significant effect on communities in two or more electoral divisions. An amended version of the Forward Plan of Key Decisions, for October 2017 to January 2018, has been published in order to:

- include a new decision in the Finance and Resources portfolio: 100% Business Rate Retention Pilot Area in 2018/19 (October 2017)
- amend two decisions in the Infrastructure and Highways portfolio:
 - Lyminster Bypass – Planning Application has been moved to December 2017 as further work is needed on the scheme following discussions with the Environment Agency
 - A284 Lyminster Bypass – Land Acquisition has been moved to February 2018 in accordance with the amended timeline.
