The Forward Plan contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months. Key decisions are those which involve expenditure or savings of £500,000 or more or which will have a significant effect on communities in two or more electoral divisions. An amended version of the Forward Plan of Key Decisions, for October 2016 to March 2017, has been published for the following reasons:

- The decision-maker for the decision on 'Procurement Strategy for Residual Waste Streams' (Residents' Services) has changed
- The decision on the 'Community Risk Management Plan 2016-20' (Residents' Services) has been taken
- The decision on 'Highway Infrastructure Asset Management Policy and Strategy' (Highways and Transport) has moved to December 2016
- The decision on 'Outline Business Case for re-procurement of the Highways Maintenance Contract' (Highways and Transport) has been replaced with 'Approval for the commencement of re-procurement of the Highways Maintenance Contract 2018' as the outline business case now informs this rather than being a separate decision.
