The Health and Adult Social Care Select Committee's Business Planning Group agreed to call-in the proposed decision by the Cabinet Member for Adult Social Care and Health concerning the Procurement of Community Reablement Service, published on the Executive Decision Database on 12 December 2016 and in the Members' Information Service on 14 December 2016 (decision ASCH7(16/17) refers). The reasons for accepting the call-in were that the request was supported by six members of the Council and it is a decision that the Committee can or would expect to preview. The call-in was initiated by Mr M G Jones with the support of Mr Lamb, Mrs Mullins, Mrs Smith, Mr Quinn and Mr Oxlade.
