All 7(a) **Options for Improved Control and Management at Household Waste and Recycling Sites**

The report outlines the recommended policy changes in relation to improved control and management at Household Waste and Recycling Sites, in particular to discourage cross-border traffic from out of county, reduce site congestion and take the opportunity to further reduce commercial waste abuse from businesses. At its meeting on 15 November 2017 the Committee requested that site survey data and options be further considered. The Committee will be asked to comment on the proposals with a view to a key decision being taken in February 2018.

All 7(b) **Strategic Challenges in Waste**

The Director of Energy, Waste and Environment will provide a verbal overview of the challenges related to the current and future management of municipal waste and recycling in West Sussex.

All 8 **Rights of Way (ROW) Management Plan 2018-28**

The report presents the draft West Sussex ROW Management Plan, covering the period 2018 to 2028, which sets out West Sussex County Council's approach to managing the Public Rights of Way (PRoW) network. The Plan also outlines the way in which improvements could be achieved in the future. The Committee will be asked to consider the draft ROW Management Plan, in particular the objectives and action plan, and to support the Plan prior to a decision on formal adoption by the Cabinet Member for Environment.

All 9 **Business Planning Group Report**

The report provides an update to the Committee of the Business Planning Group (BPG) meeting held on 7 December 2017, setting out the key issues discussed. The Committee will be asked to endorse the contents of the report and the Committee's Work Programme for 2017/18 and 2018/19, revised to reflect the BPG's discussions.

All 10 **Requests for Call-in**

The Environment, Communities and Fire Select Committee Business Planning Group received a request to call-in the proposed decision by the Cabinet Member for Highways and Infrastructure concerning the approval to proceed with the procurement and implementation of a Crawley Street lighting LED conversion programme – decision published on the Executive Decision Database on 20 December 2017 and in the Members' Information Service on 27 December 2017, HI24(17/18) refers. The Forward Plan contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months.
