On 26 May 2017, the West Sussex Joint Minerals Local Plan (prepared by the County Council and the South Downs National Park Authority) was submitted to the Government. Mr Jonathan Manning, an independent Planning Inspector, has been appointed to conduct an Examination-in-Public (EiP) to determine whether the Plan is 'sound' and 'legally compliant'.

The Planning Inspector has now issued his 'Matters and Issues' and confirmed that the EiP public hearings will begin on **Tuesday, 19 September 2017** and run for two weeks (Tuesdays to Thursdays). The hearings will be held at Edes House, Chichester. A [public examination](#) webpage has been set up that contains further information about the EiP. All relevant documents, including the Matters and Issues and the draft hearing programme, are held in the [Examination Document Library](#). Subject to the outcomes of the EiP, it is anticipated that the Plan will be adopted in May 2018.

The Forward Plan contains details of all key decisions to be taken by the County Council, the Cabinet, Cabinet Members, County Local Committees and officers in the following four months. Key decisions are those which involve expenditure or savings of £500,000 or more or which will have a significant effect on communities in two or more electoral divisions. An amended version of the Forward Plan of Key Decisions, for August to November 2017, has been published in order to:

- Include a new decision in the Leader portfolio - Procurement for the award of contracts to provide Discharge to Assess with Reablement care services (September);
  - Include a new decision in the Finance and Resources portfolio - Appointment of a Multi-disciplinary Development Consultant – Property (August);
  - Move the Procurement of Fire and Rescue Communications Equipment in the Stronger, Safer Communities portfolio to August as the recommendations continue to be finalised; and
  - Move the Refinancing of the Street Lighting Private Finance Initiative (PFI) contract decision from the Infrastructure and Highways portfolio to the Finance and Resources portfolio as the focus of the decision is upon financing.
