All 4 **Cabinet Member's response to the Committee's recommendations**

(a) **County Council's proposed response to the Department for Transport's (DfT's) consultation on the creation of a Major Road Network (MRN)**

The Committee will be asked to note the Cabinet Member's response to the Committee's recommendations on the County Council's proposed response to the DfT's consultation on the creation of a MRN.

(b) **Fire & Rescue Service and Performance of the Substance Misuse Contract**

All 5 **A27 Chichester Bypass Improvements: Submission to the Government's Roads Investment Strategy**

In July 2016, Highways England published five options for improving the A27 at Chichester, for public consultation. As none of the options secured support from a majority of the consultation respondents, the Secretary of State wrote to Highways England cancelling the scheme because of the lack of local consensus. In response, the County Council convened a community meeting to try to develop a way forward as part of the 'Build A Better A27' initiative. Consultants were appointed to provide independent technical advice and support to promote a scheme for inclusion in the Government's second Roads Investment Strategy (RIS2 - 2020-25). As a result of this work, there are now three potential approaches to promoting a scheme to the Government for inclusion in RIS2.

The Committee will be asked to note the outputs of the work by the Community Group and consultants and to submit its views to the Cabinet Member for Highways and Infrastructure on: the desirability of the options; the suggestion that Approach C is taken forward; and the suggestion that the 'mitigated northern route' be identified as the County Council's preferred option.

All 6 **Growth Deals**

At its meeting on 31 January 2018, the Committee requested an update on progress with current Growth Deals that have been developed with districts and boroughs to enable resources to be aligned to support and facilitate the delivery of key and agreed growth priorities. The Committee will be asked to consider and note the progress made to date, the current status of the programmes being delivered through the Deals and asked to support the proposed next steps.
