

## Wildlife and Countryside Act 1981

The Definitive Map and Statement of Public Rights of Way in West Sussex

To: West Sussex County Council; Surveying Authority

I Paul Edward Morris Brown, of "Ashurst", Bulldogs Bank, Top Road, Sharpthorne, East Grinstead RH19 4PH hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:-

Adding the bridleway **from** the public highway at Sharpthorne Road, West Hoathly Map Ref. 135 TQ 374325 **to** footpath 51 FR Map Ref. 135 TQ 376336 in accordance with section 53(3) (c) (i) of the Act. (A-B on the application plan)

Modifying the record to record bridleway rights on the entire length of existing footpath 51 FR currently shown on the East Sussex definitive map and statement and add the way to the West Sussex definitive statement and map. The way runs **from** Map Ref. 135 TQ 376336 **to** footpath the public vehicular highway Map Ref 135 TQ 379340 in accordance with section 53(3) (ii) of the Act.(B-C on the application plan)

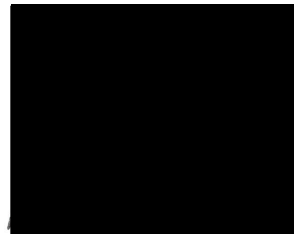
