# Make the Commitment campaign

#### What is 'make the commitment''?

Make the commitment is part of West Sussex County Council's strategy to reduce speed related casualties. It encourages drivers to make a personal pledge to drive within the speed limit. Make the commitment is part of the long term campaign designed to make speeding as socially unacceptable as drink driving.

#### Make the commitment - brief history

Make the commitment was conceived in 1994 and launched in early 1995, initially in Suffolk. The campaign rapidly gained popularity. In turn Hertfordshire, Essex and Cambridgeshire adopted 'make the commitment'. It was piloted in Norfolk and taken up by Luton Borough Council, Thurrock Council and Peterborough City Council. Away from the eastern region, 'make the commitment' has been launched by East & West Sussex Council, Brighton & Hove Council and North Yorkshire Council.

#### How 'make the commitment' works

It's simple. The motorist is asked to make a written commitment to try to drive within the speed limit at all times. The form is on a leaflet which is available from Gill Starkie, West Sussex County Council,

## Your Council – Roles and Responsibilities

#### The Clerk and Proper Officer

The Clerk is employed by the Council (under section 112 (1) of the Local Government Act 1972) to provide administrative support for the Council's activities. Any other staff, although employed by the Council, answers to the Clerk who is their manager and is responsible for their performance.

The Clerk's primary responsibility is to advise the Council on whether its decisions are lawful and to recommend ways in which decisions can be implemented. To help with this, the Clerk can be asked to research topics of concern to the Council and provide unbiased information to help the Council to make appropriate choices. The Clerk has a wide range of other responsibilities which are set out in the job description.

The Clerk must recognise that the Council is responsible for all decisions and that he/she takes instructions from the Council as a body. The Clerk is not answerable to any individual councillor – not even the Chairman. The Council must be confident that the Clerk is, at all times, independent, objective and professional.

The 'Proper Officer' is a title used in statute. It refers to the appropriate officer for the relevant function. In town and Parish Councils, the proper officer is normally the Clerk. In financial matters, the proper officer is known as the Responsible Financial Officer.

## The Chairman

The Chairman is elected by the members of the Council at the Annual Council meeting and serves for twelve months (Section 15 (1) of the Local Government Act 1972).

The Chairman's main role is to run Council meetings. The Chairman can suggest the content and design of the agenda, but as legal signatory, the Clerk has the final say. The Chairman is responsible for ensuring that effective and lawful decisions are taken at meetings of the Council, and, assisted by the Clerk, guides activities by managing the meetings of the council. The Chairman is responsible for involving all councillors in discussions and ensuring that councillors keep to the point. The Chairman summarises the debate and facilitates the making of clear resolutions and is responsible for keeping discussions moving so that the meeting is not too long. The Chairman has a casting vote. The Chairman's first vote is a personal vote as a member of the Council. If there is a tied vote, the Chairman can have a second, casting vote.

The Chairman will often be the public face of the Council and will represent the Council at official events. The Chairman may speak on behalf of the Council in such circumstances and should express the agreed views of the Council and not personal views. The Chairman cannot legally make decisions on behalf of the Council.

### The Prince's Trust – helping young people into rural business

The Trust is the largest youth charity in the UK with the main target group being termed 'disadvantaged young people' including young people who are unemployed or under-employed, educational under-achievers; offenders and ex-offenders; and those in or leaving care. # **Recycling household batteries**

All Civic Amenities Sites in West Sussex now have containers for household batteries like those found in electrical appliances, toys and mobile phones, rechargeable or single use, including nickel cadmium, nickel metal hydride, lithium, lithium-ion, alkaline manganese, silver oxide, zinc carbon, mercury oxide etc can be recycled by disposing of them in the 'sweet jar' looking battery containers. The majority of these containers are placed next to the car battery containers already in use.

The batteries collected from the Civic Amenities Sites in West Sussex by G & P Batteries Ltd are among the first to be collected for recycling in the UK as, up until now, all household batteries collected have had to be exported. From early 2005, G & P Batteries will be operating their own battery recycling facility in West Bromwich for all alkaline batteries which make up about 85% of the batteries used in the UK

#### Your Bobbies on the Beat

Sussex Police Horsham District – Current Local Police Contacts; Sgt Bob Trevis; PC Martin Harris and PCSO Sybil Yeo mobile 07990 715156 (Police Community Support Officer).

Offences for which the PCSO is empowered to make decisions regarding action are:

- \* issue a Fixed Penalty Notice (FPN) for dog fouling, littering and riding on footpaths
- \* to request name & address for FPN offences, and offences that cause injury, alarm and distress to another person or damage or loss to another person's property
- \* to request the name & address of a person acting in an antisocial manner
- \* to request a person to stop drinking in a designated public area and to surrender containers of alcohol
- \* to confiscate alcohol cigarettes & tobacco products from young people
- \* entry to premises to save life or limb, or to prevent serious damage to property
- \* to seize vehicles used to cause alarm and distress
  - \* require removal of abandoned vehicles
  - \* stop a vehicle for emissions testing
- \* regulate traffic for purposes of escorting abnormal loads
- \* stop vehicles for purpose of read check (in the presence of a police officer in uniform only)
- \* maintain and enforce a cordoned area established under the Terrorism Act
- \* driving elsewhere than a road for more than 15 yards (Fixed Penalty Notice or verbal warning)
- \* failing to Exhibit Excise Licence (Fixed Penalty Notice)
- \* unnecessary obstruction of highway (Fixed Penalty Notice)
- \* Waiting where prohibited (loading & offloading) (Fixed Penalty Notice)
  - \* Limited waiting (Fixed Penalty Notice)
- \* Parking an HGV on the Footpath or Verge (Fixed Penalty Notice)
